We will continue to offer a free room for both Friday and Saturday nights to our out of town vendors, but rooms are limited, and will be assigned in the order registration forms are received. Don't wait, get signed up now! Along with your registration form, please provide us with a Certificate of Insurance naming Chillin 'n Swillin, Inc. and the Chillin 'n Swillin Beer Festival and its agents as additionally insured.

- Because this event is held on the grass at London Bridge Beach, no glass products can be distributed or sold, but vendors are allowed to pour from glass bottles if necessary.
- To comply with Arizona State liquor laws, beer samples can only be poured in the tasting mugs we provide, and vendors will be asked to collect tickets. In addition, vendors, employees, and volunteers may *not* consume alcohol while serving beer during the event.
- No alcohol may leave the boundaries of the event, so glasses, growlers and bottles may not be given out or sold.
- If you have a request to be located next to a specific vendor, please let us know in advance and we will do our best to accommodate you. Vendor sites will not be changed the day of the event.
- There is a one day, temporary special event business license that is required by Lake Havasu City. Chillin 'n Swillin, Inc. will complete the application and cover the cost of the fee for out of town vendors.

Set up may begin at 10:00 a.m. and we ask that you be completely set up by 12:00 p.m. Gates open promptly at 1:00 p.m. Ice and trash pick-up will be provided throughout the event.

- Beer vendors shall provide a Certificate of Insurance naming Chillin 'n Swillin, Inc., Chillin 'n Swillin Beer Festival and its agents as additionally insured or provide a copy of your liability insurance policy.
- Beer vendors, their staff members, guests, and/or volunteers may not consume alcoholic beverages while serving beer during the event. Beer vendors are responsible for their staff members and/or guests that are pouring for them.
- Beer vendors, their staff members, guests, and/or volunteers understand they will not serve any obviously intoxicated person as per A.R.S. § 4-244(14). In the event that an obviously intoxicated patron is identified, a beer festival organizer or event security will be notified immediately.
- This event is for adults 21 years of age or older, and there will be no exceptions. No children or pets are allowed.
- Set up will begin at 10:00 a.m. Please be completely set up by 12:00 p.m.
- Gates open promptly at 1:00 p.m.
- Last call is at 4:30 p.m. with the last pour at 4:45 p.m. Gates will close at 5:00 p.m.
- Beer vendors are responsible for cleaning up and leaving their site and tables clean and free of trash, bottles, and bottle caps. All trash will be placed in the designated trash containers.
